In the flourishing vegetation along the sea shore, near Saint Jacob' church, Iginio Scarpa, a merchant and patrician of Rijeka, built a villa in 1844 surrounded by a flower garden and park. He named it Villa Angiolina in honor of his wife. The hospitable married couple opened wide the doors of their summer house. The first «real» tourists began coming to St. Jacob's Abbey.

This marked the beginning of Opatija's tourist development.



Lungomare - Built in phases, this path stretches from Preluka to Lovran and its total length is approximately 12 kilometers. Planned as an important trump card for health tourism, this path, together with the parallel woodland path in the town's hinterland (today's Carmen Sylva Promenade) is a potential of psychophysical recreation that is indeed insufficiently exploited. In addition to this, the Promenade passes by most of the significant structures of Opatija's history, linking the old sanatoriums of the North Strand, the port, Lido, villas Angiolina and Amalia, hotel Kvarner, St. Jacob's church and finally the hotels with the villas of the South Strand.
